How to Use the Read Ahead Contract



As teachers, we see readers of all levels. It can be a challenge to help our strong readers go at an appropriate pace, while still making sure that they learn to analyze text – not just decode it. This Read Ahead Contract can help differentiate instruction for your strong readers!

In the Read Ahead Contract, the student agrees to a few conditions in exchange for permission to read ahead, either in a single story or in general.

To use the Contract:

- ✓ Send home the Note to Parents so they understand the principle and keep the signed copy for your records when it is returned.
- Discuss the idea with the student.
- ✓ Decide on a length for the Contract. You can make it the length of a single story the class is reading, or for a longer period of time (such as a week or two). It's best to not have it go too long early on, as you may find it needs to be tweaked!
- ✓ Have the student read the conditions and check the boxes next to each one.
- ✓ The student should come up with three options for things he/she can do when he/she has finished the assigned reading. Ideas include reading a different book (I recommend Mensa's Excellence in Reading Program – find out more at mensaforkids.org – a free program that allows readers to earn a free t-shirt & a certificate); going to the library to browse or read magazines; completing a different reading related activity like writing a letter or creating something connected to the story; or listening to an audio book.
- ✓ The teacher will choose the student choice the teacher prefers. If the student completes that choice, the teacher will pick another one.
- ✓ The contract may be revoked at any time if the student violates the terms, although you may wish to give warnings while the student is getting used to how it works.
- ✓ Keep a copy of the Contract in your records, and send a copy home
 to the parent(s).
- ✓ Be sure to list this as a differentiation strategy for your readers.

Dear Parents,

You will notice that students need to come up with three possible ideas for what they will do when they have finished the reading and the class is still reading. I have ideas I will share with the student, and you are welcome to come up with ideas as well. Of the three ideas the child selects, I will choose the one that I feel is the best fit for the child in the classroom setting at that time.
